Beef meat for local market is mainly coming from imports from regional market and a very low

percentage is produced by local farmers.



Surface area that will be transferred to this NewCo can be changed as a result of land consolidation process. New Co is located in a single plot in two cadastral zones Tërstenik and Gllobar. This agriculture complex lies in the north of the Gllogoc city 30 km away from the capital Pristina and 5 km

away Gllogoc city.
