SOE Name	SOE "Univerzal" (the "Enterprise")
Name of NewCo	NewCo Univerzal Warehouse L.L.C. (the "Subsidiary")
Location	Leposavic Municipality
Business/Sector	Storage/trade activities
Products	The NewCo offers warehouse space for rent to private sector.
Market	The main customers for warehouse space are trading companies, which store goods for sale and sometimes also use the warehouse as a point-of-sale. In addition, industry uses the warehouses as workshops and production halls.
Employees	According to data from 2003, SOE Univerzal approximately employs 20 people on a part time basis and supplies financial assistance to 115 additional people. The management of SOE is not willing to cooperate with PAK RO; therefore no updated data is available related to this issue.
Buildings and Land	There is 7,497m ² of land allocated to the NewCo. Approximately 2,655m ² of constructed space is divided among a main warehouse of about 2,465 m ² , an administrative building of about 182m ² and a security gate of 8m ² . The warehouse is divided into 4 similarly sized independent storage areas. The NewCo Warehouse Univerzal L.L.C. property is on parcel no. 2544 possession list no.357, located in Slaniste –Leposavic, Currently the management of the SOE is not willing to cooperate with PAK RO in Mitrovica and therefore no data is available related to the state of the property that will be retendered in wave 54.
Competition	In Leposavic town there are around 6 warehouses that may be used for both industrial or trade purposes. The Subsidiary is located in Leposavic downtown where 5 other warehouses are located.
