**Location** Village Shilovo of Gjilan/Gnjilane Municipality.

**Business/Sector** Agro Food Processing Industry

**Products** The main service of the Enterprise is cold storage of meat,

fruits, vegetables and ice cream. The cold storage facilities consist of 6 chilling rooms, in total capacity of 12880 m<sup>3</sup>. The temperature can be adjusted separately for each chamber.

The Refrigeration Plant is also processing and packing fruits and vegetables (cherries, plums, mushrooms, paprika, tomatoes, strawberries, etc.) for cold storage or distribution.

Market The natural market for the plant is agro-combines and meat,

fruit and vegetable processing plants in the region. The plant also uses to serve minor clients Kosovo wide as logistic centre

for distribution of meat, ice cream and imported fruits.

**Competition** The Refrigeration Plant is the only cold storage in the eastern

part of Kosovo. There is a similar cold storage in Nis (Serbia)

and a minor cold storage in Prizren.

**Employees:** At present the SOE have 4 employees. However, none of the

employees will be transferred to the NewCo.

- behalf of employees of the SOE in their capacity as employees), arising in the normal course of business during the 3 month period ending on the date of the completion of the sale of the Subsidiary;

  - a) accrued during the three month period ending on the date of entry into force of the relevant declaration of transfer;
