<b>Name of NewCo</b>	<b>NewCo Agricultural Land Siqevë L.L.C.</b> (The NewCo)
<b>Location</b>	Village Siqevë/o, Municipality of Klinë/a
<b>Business/Sector</b>	Agronomy, Agribusiness
<b>Products</b>	Cultivation and trade of various crops and vegetables.
<b>Market</b>	The NewCo will enable the future owner to invest and pursue agricultural activities on an industrial scale. Both size and location of the fertile land will facilitate to recapture past market shares in Kosovo and beyond and with optimal investment in modernised machinery, knowledge and cultivation techniques, the commercial prospects of the NewCo are promising.
<b>Competition</b>	A minimal competition from local farmers is expected, while foreign predominant import of agricultural goods may be a challenge.
<b>Employees</b>	None of the workers are associated with the NewCo.

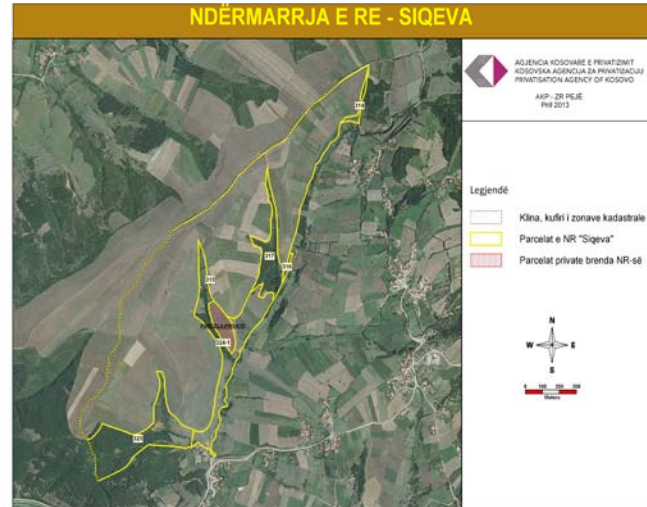
