crops primarily for the Kosovo market, which is currently characterised by imports averaging 50% of total consumption for wheat, 60-70% for maize and almost 100% for soybean and extremely high feed grain prices given

transport and taxation costs.

Employees: The Enterprise has currently 24 active employees.
