NewCo's offering includes small plot of land and premises.

Location Komoran village, Gllogovc/Gllogovac Municipality

- Business/Sector Agribusiness
- **Products** The Enterprise was historically dealing with processing, collecting, supply with inputs and marketing of its member's products.
- Market The enterprise is not operational.
- **Competition** Small plot of land and premises can be used for various commercial and agribusiness activities and is very suitable for storage or can be used for new construction with appropriate investment.
- **Employees** The SOE actually has 7 no active employees, none of these will be transferred to the NewCo.
- **Buildings and Land** The land to be transferred to the NewCo Komorani L.L.C. includes an approximate surface area of 4589m<sup>2</sup> (45 ar and 89 m<sup>2</sup>) and premises with a surface area of 1465<sup>2</sup> (from these premises only 545m<sup>2</sup> are registered in the certificate for the immovable property rights). NewCo is located in cadastral zone Komoran and is situated approximately 700 meters away from Komoran junction.
- **Liabilities to be Transferred** The standard final 3 months of accounts payable and last twelve months of property tax and VAT related to the unit will be transferred to the NewCo. The other liabilities will remain with the AC. There are no mortgages on the assets to be privatised.
