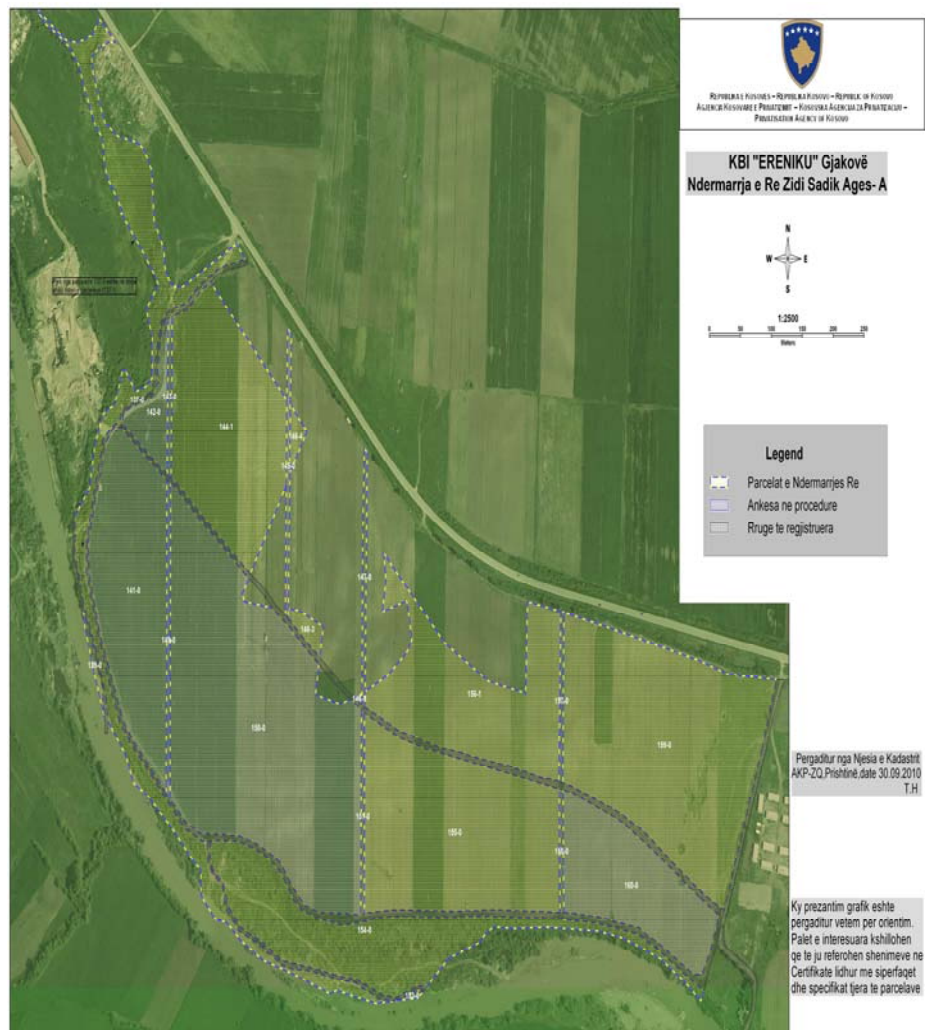

| <b>Location:</b>                      | Ura e Terzive suburbs of Gjakova city, Municipality of Gjakova   |
| <b>Business/Sector:</b>               | Agriculture, Agribusiness  |
| <b>Products:</b>                      | Cultivation of different crops and fruit trees (tree plantation)   |
| <b>Market:</b>                        | During its final operations, the Enterprise sold solely in Kosovo. The market for agricultural products is now dominated by foreign imports, competition from local regional farmers being limited.  |
| <b>Competition:</b>                   | The enterprise has the potential to play a major role in production of cereal crops primarily for the Kosovo market, which is currently characterised by imports averaging 50% of total consumption for wheat, 60-70% for maize and almost 100% for soybean and extremely high feed grain prices given transport and taxation costs. |
| <b>Employees:</b>                     | The Enterprise has currently 24 active employees.  |
| <b>Buildings and Land:</b>            | NewCo Agricultural Land Zidi i Sadik Agës A L.L.C includes the farmland with a surface approximately 390712 m <sup>2</sup> (39 hectares 07 are 12 m <sup>2</sup> ) of good quality arable land.  |
| <b>Liabilities to be Transferred:</b> | The standard final 3 months of accounts payable, last twelve months of VAT and last twelve months of property tax will be transferred to the NewCo. The other liabilities will remain with the SOE. There are no mortgages on the assets to be privatised.   |
