<b>SOE Name</b>	AIC "Ereniku" - SOE "Ereniku Primary Production", Gjakovë/Djakovica (the "Enterprise")
<b>Name of NewCo</b>	<b>NewCo Agricultural Land Rracaj L.L.C.</b> ("The NewCo")
<b>Location</b>	Gjakova/Djakovica Municipality.
<b>Business/Sector</b>	Agriculture, Agribusiness
<b>Products</b>	Cultivation and trade of various crops and vegetables.
<b>Market</b>	During its final operations, the Enterprise sold solely in Kosovo. The market for agricultural products is now dominated by foreign imports, competition from local regional farmers being limited.
<b>Competition</b>	The enterprise has the potential to play a major role in production of several crops primarily for the Kosovo market, which is currently dominated by foreign import.
<b>Employees</b>	None of the Enterprise workers is associated with the NewCo.
<b>Buildings and Land</b>	<b>New Co Agricultural Land Rracaj L.L.C.</b> includes a complex of agricultural land with surface of 108ha, 39ari and 17m <sup>2</sup> (1083917 m <sup>2</sup> ) which lies in 4 cadastral zone of Gjakova/Djakovici Municipality, registered in the following ownership certificates: - UL-70705041-00104 CZ Kusar/Kodra Hutit; - UL-70705055-00217 CZ Osek Hile; - UL-70705071-00006 CZ Skivjan; - UL-70705066-00122 CZ Rracaj.
